Gjøco Kraftvask is an alkaline cleaning product for outdoor surfaces. It efficiently removes stickiness, impurities and black mold before recoating. Gjøco Kraftvask has a light matting effect on existent paint and is there for suitable for use before application of new paint.

NOTE: Becomes corrosive on aluminium and metals. Etches glass – windows need to be covered or rinsed clean immediately.

Directions for use	The surface needs to be dry before application. Apply Gjøco Kraftvask with even movements down to up and make sure that all areas are covered. Avoid waste on dry surfaces. Leave the product on for 2-5 minutes (don't let it dry out). Heavily soiled surfaces should be washed with brush or broom. Use a garden hose and rinse with clean water from top to bottom. High pressure washer can be used but beware that this can damage the woodwork and cause penetration of water. Don't use the product in direct sun. Avoid spraying Gjøco Kraftvask directly on plants. In case of waste, wash with water.	
Storage	Screw the top back on when storing to prevent spillage and drying out. The product must be transported and stored upright, dry and frost-free.	
Disposal of waste	The product must not be emptied into sewers or into nature, but delivered to an environmental station. Empty, clean, and dry plastic packaging can be delivered as plastic waste.	
Other information	Contains Sodium Metasilicate and Iye (Sodium Hydroxide). The solution is cauterizing. Must not be swallowed. Store in a locked compartment and inaccessible for children. Use gloves and eye protection. Avoid contact with eyes, the product contains Iye. In case of contact with eyes, wash immediately with plenty of clean water. In case of accident or sickness, immediate medical care is needed. See Safety Data Sheet. Packaging sizes: 1 and 4 litres.
