Gjøco Grønske- og Algefjerner



Gjøco Grønske- og Algefjerner removes effective unwanted growth of fungi, greens, algae or lichen. Can also be used for surface disinfection. Used on outdoor roofs, stone, walls, facades and terraces. Do not apply when there is a risk of rain, night frost or in direct sunlight. Dead material is naturally removed by rain or wind. Optionally, surfaces can be flushed or easily cleaned. Delivered both with and without an ejector.

Technical data

Type: Fungi, greenish and alga disinfectant.

Specific gravity: 1.0 kg/l

Usage data

Application method: Ejector that connects to a garden hose, or spray bottle/low pressure sprayer.

Recommended spreading rate: Approx. 10 m²/liter depending on fouling.

Mixing ratio: Use undiluted.

Minimum application temperature: >10°C. Best effect at 15 - 20 °C.

Application time: To be used in period between April – September.

Pretreatment

It is recommended that loose fungi, greens, lichens and others are removed before treatment. This results in less consumption of Gjøco Grønske- og Algefjerner.

Directions for use

Gjøco Grønske- og Algefjerner is used undiluted. When using the ejector, the jug is connected to the garden hose, and dosing takes place automatically. Spray on liberally so that the growth is well moistened. Repeated treatment should be considered in case of strong growth, preferably at 2–3-week intervals. Dead material is removed when it has turned brown, either naturally by rain and wind, or by sweeping or flushing. Do not use high pressure washers on roofs. When treating delicate surfaces such as textiles, the product should not dry in, but should be rinsed off. Always do a test first, to see if the material can withstand the treatment.

Storage

Screw the top back on when storing to prevent spillage and drying out. The product must be transported and stored upright, dry and frost-free.

Disposal of waste

The product must not be emptied into sewers or into nature but delivered to an environmental station. Empty, clean, and dry plastic packaging can be delivered as plastic waste.



Other information

It is not recommended that the ejector be unscrewed from the packaging, as this may lead to leakage. Packaging sizes: 2.5 and 4 litres.
