It penetrates well into the wood, providing effective impregnation while forming a weather-resistant film. Herregård Exclusive Oljebeis is used on new or previously stained wood surfaces. It can also be used on pressure-treated materials. No primer is required.

Application Instructions	Substrate:	The surface must be dry and free of frost, with a minimum temperature of -5 °C.
	Application Methods:	Brush, roller, or spray. Spraying should be carried out by professionals.
	Thinner:	White Spirit, thinning is normally not necessary.
	Storage:	Store and transport upright, dry, and frost-free, out of reach of children.
	Transport:	Not classified as dangerous goods under applicable regulations.
	Indoor Environment/Emission:	The product is intended for outdoor use.

Maintenance	Cleaning:	For annual cleaning, Gjøco Husvask is recommended For cleaning before repainting, Gjøco Kraftvask is recommended. Follow the instructions on the product label. Newly painted wood should not be washed for 3-4 weeks.
	Interval:	The paint film naturally breaks down due to weather exposure, and this will vary depending on local conditions. Repainting should be done as needed, particularly when the film becomes dull and worn. Weather-exposed walls typically require more frequent
