Gjøco Herregård Treolje XO is a high-quality impregnating wood oil with a film-preserving agent to prevent mold growth. It helps prevent greying and cracking of pressure-treated wood. Herregård Treolje XO is used on outdoor terraces, privacy screens, garden furniture, and other pressure-treated wood materials. For light-colored wood, it is recommended to use pigmented oil for better protection.

Application Instructions	Substrate:	The surface must be clean, dry, and have a minimum temperature of +5°C.	
	Application Methods:	Brush or roller.	
	Thinner:	White Spirit, thinning is usually not necessary.	
	Storage:	Store and transport upright, dry, and frost-free, out of reach of children.	
	Transport:	Not classified as dangerous goods under applicable regulations.	
	Indoor Environment/Emission:	The product is intended for outdoor use.	
Technical and Safety Data	A technical data sheet and safety data sheet (SDS / MSDS) have been prepared for the product. See www.gjoco.no. VOC: EU limit for the product (cat. A/e): 700 g/l (2010). The product contains <600 g/l VOC.		
Maintenance	Cleaning:	For annual cleaning, Gjøco Kraftvask is recommended. Use Gjøco Terrasserens for heavily soiled surfaces before re-treatment. Follow the instructions on the product. Newly painted wood should not be washed until after 3-4 weeks.	
	Interval:	The paint film naturally breaks down due to weather exposure and will vary based on local conditions. Repainting should therefore be done as needed, when the film becomes dull and worn.
