Gjøco Taksteinolje is a weather-resistant oil for outdoor use on roofs. It has high water-repellent properties and good weather resistance. It contains a film-preserving agent to prevent the growth of black mold, moss, and algae. It is suitable for most types of roof tiles such as concrete, clay, cement tiles, and asbestos cement. It is not suitable for certain types of super/flat asbestos cement that are very smooth.

	Application Methods:	Wide brush designed for oil. Spraying should be done by professionals.	
	Thinner:	White Spirit.	
	Storage:	Store and transport upright, dry, and frost-free, out of reach of children.	
	Transport:	Not classified as dangerous goods under applicable regulations.	
	Indoor Environment/Emission:	The product is intended for outdoor use.

Maintenance	Cleaning:	For annual cleaning, Gjøco Husvask is recommended. For cleaning before repainting, Gjøco Kraftvask is recommended. Follow the instructions on the product.	
	Interval:	The paint film naturally breaks down due to weather exposure and will vary based on local conditions. Repainting must therefore be done as needed, when the film appears dull and worn. The weather wall(s) are more exposed to the weather and typically require more frequent repainting than the rest of the building.
