## Gjøco Sopp- og Algefjerner



Gjøco Sopp- og Algefjerner effectively kills unwanted growth of fungus, moss, algae, or lichen. It can also be used for disinfecting surfaces. Suitable for use on outdoor roofs, stone, masonry, facades, and terraces. Do not apply if there is a risk of rain, night frost, or in direct sunlight. Dead material is naturally removed by rain or wind. Alternatively, the surface can be rinsed or brushed clean. Supplied with an ejector that connects directly to a garden hose.

Application method:	Ejector connected to a garden hose
Consumption:	Approximately 10 m <sup>2</sup> per liter, depending on growth
Mixing ratio:	Use undiluted
Minimum application temperature:	>10°C. Best results at >+15 - 20°C
Usage period:	Use between April and September

### Pre-treatment:

It is recommended to remove loose fungus, moss, lichen, and similar growth before treatment, as this reduces the consumption of Gjøco Sopp- og Algefjerner.

<b>Application Method:</b>	<p>Connect the canister to the garden hose, and the dosing happens automatically. Spray generously to thoroughly wet the growth. A repeated treatment should be considered for heavy growth, preferably with 2-3 weeks in between. Dead material is removed once it turns brown, either naturally by rain and wind or by brushing or rinsing.</p> <p>Note: A pressure washer on the roof should be used with caution. When treating delicate surfaces, such as textiles, the product should not be allowed to dry but should be rinsed off. If unsure whether the material can withstand the treatment, it is recommended to test on a small area first.</p>
<b>Storage:</b>	The product should be transported and stored upright, in a dry and frost-free environment.
<b>Eco-labeling</b>	<p>BREEAM-NOR v6.1:          – MAT02: Contains no substances listed under REACH Article 59(10) – the Candidate List and the Norwegian A20 list. See also the product safety data sheet.</p>
<b>Waste Disposal:</b>	<p>The product should not be emptied into sewage systems or the natural environment but should be taken to a recycling station. Empty, clean, and dry plastic packaging can be disposed of as plastic waste.</p> <div style="text-align: center;">  </div>
<b>Additional Information:</b>	It is not recommended to remove the ejector from the packaging, as this may cause leakage. Packaging sizes: 2.5 liters.
<b>Safety:</b>	Refer to the safety data sheet. Read the information on the packaging.
